John F. and Dorothy R. Kerker Memorial Business Scholarship The Kerker Family provides this award annually to a sophomore business student. The scholarship will be based on need, ability to demonstrate leadership skills, and scholastic interest. Applicants must include a letter of recommendation and an essay on the topic "Why I Chose the Field of Business." The student must carry a 3.0 GPA or better. The Business Office makes the selection, and the amount varies based on availability of funds.
Bernadine Parr Memorial Scholarship Established in 1998 in memory of Bernadine Parr, a longtime NJC employee. One \$500 scholarship will be awarded to an NJC sophomore business student who is also a resident of Logan County. Applicant must have a 3.3 GPA at the end of their freshman year of college.
Bruce C. & Sharon L. Perryman Presidential Emeritus Scholarship This \$500 scholarship is awarded to a resident of Colorado or Wyoming majoring in secondary business-teacher education. Student athletes, Iraq or Afghanistan war veterans, or members of the Future Teachers Association will be given preference. The recipient must hold a cumulative 2.5 GPA at the end of the student's freshman year.
Kenneth E. and Theda C. Anderson Business Scholarship This \$1,000 scholarship is awarded to a declared business student working towards a degree of either an A.A. in business (DwD) or A.A.S. Business. The recipient must demonstrate need for financial assistance, and can be either an incoming freshman or continuing student with at least a 3.0 GPA. Applicants must include two letters of recommendation, and an essay (200-250 words) on the topic "Tell us about your business role model."

Barbara Kaiser Memorial Scholarship

This Scholarship is awarded to a freshman or sophomore female NJC business student who is from the fivecounty service area (Logan, Phillips, Sedgwick, Washington, or Yuma County). The recipient must hold a cumulative 3.0 GPA or higher. The Business Division makes selection, and the scholarship amount varies based on availability of funds.

Business and Professional Women of Sterling Scholarship

This \$500 Scholarship is awarded to a full-time freshman or sophomore NJC female student who is from the five-county service area (Logan, Phillips, Sedgwick, Washington, or Yuma County). The recipient must hold a cumulative 2.5 GPA or higher.
