

## Northeastern Junior College Student iPad Rental and Usage Agreement

*The undersigned student is being issued an iPad through the Northeastern Junior College (NJC) Student iPad Rental Program to conduct activities related to their coursework. However, NJC recognizes that an NJC issued iPad may also be used for personal reasons. The use of an NJC issued iPad is a privilege and all students are expected to use them responsibly. NJC expects all students using NJC issued iPads to use them in a safe manner at all times. Misuse of the iPad will result in the loss of this privilege without proration or refund of the rental fee paid and possible disciplinary action.*

- I understand I am being provided with an **iPad, USB cable, wall charger, and protective cover (collectively the iPad Bundle)** and that all of these items must be returned at the end of the rental period and/or if I leave NJC for whatever reason, or at any time requested by NJC, in a manner that would allow them to be reissued without additional expense.
- I understand I will be charged a fee for the rental of this iPad Bundle for as long as I retain the device. I understand that I will not be allowed to rent more than one (1) iPad Bundle per semester. The full amount of the rental fee is due and payable at the time the iPad is issued. I understand this amount is non-refundable.
- I understand that the iPad is the property of NJC and I have no expectation of privacy regarding the device or its contents.
- I understand NJC will maintain some level of control over the iPad using mobile device management software. NJC supplied applications may be pre-installed or otherwise made available. NJC retains ownership of such applications.
- I may purchase and install personal applications or purchase personal accessories for the iPad. I am personally responsible for any charges due to Apple or third parties when purchasing or updating personal applications or accessories.
- I will take appropriate steps to protect the iPad by utilizing the cover provided or purchasing a cover/case that provides protection that is equal to or greater than the cover provided.
- I will take appropriate steps to secure the data on the iPad with a password and will follow all other security requirements. I will accept financial responsibility for the disclosure of information resulting from my failure to take appropriate steps to protect the iPad.
- I will not jailbreak or otherwise tamper with the iPad operating system or attempt to alter the iPad.
- I understand that all damages and repairs must be directed to the **Information Technology Help Desk (970.521.6805)** and that I should contact them immediately if the iPad is lost or stolen. The iPad being rented is covered by the AppleCare+ service agreement. However, any damages not covered under the AppleCare+ program will be the responsibility of the Student. I understand that I am responsible for returning the iPad and related accessories to NJC at the end of the rental agreement in good working condition, normal wear and tear excepted. In the event the iPad is stolen, I am responsible for providing an official police report to NJC within two business days of the incident. I understand that I am responsible for the entire replacement cost of an iPad and/or components that are lost.

- If the iPad rented to me by NJC is lost, damaged, or stolen, or if for any other reason I am unable to return the iPad by the last day of my term enrollment with NJC, I understand that I may be charged a repair or replacement fee.
- I agree to review and follow the policies and appropriate use guidelines set by NJC. I understand that the privilege of using an NJC issued iPad may be rescinded at any time, and that if I do not follow policies and guidelines for appropriate iPad use, I may be asked to return the device prior to completing my education.
- I understand that all data and applications I have stored on the iPad will be deleted or removed when the iPad is returned. NJC will not be responsible for lost data, information, or applications left on the iPad.
- I understand that I must sign a new User Agreement each semester in order to continue renting my iPad. I further understand that failure to sign an updated agreement, pay the associated rental fee, and/or return the iPad and all of the original accessories will result in replacement charges being billed to my NJC account.
